

GUIDELINES FOR THE SPIRITUALIST'S PATHS 2 SPIRIT 100 CLUB

The 100 CLUB has been established by the Main Committee, 'Paths 2 Spirit' to assist their Fund Raising Group, 'Spiritualists Good Friday Rally' to raise funds wholly and continuously for the annual event, The SPIRITUALISTS' GOOD FRIDAY RALLY.

The 100 CLUB is run and operates under the rules for private society lotteries. And has, and must keep, a valid certificate of registration to run a private society lottery with The **Stevenage Borough Council**. The registration of this certificate is **SBCSL132**.

TO join the SPIRITUALIST'S PATHS 2 SPIRIT 100 CLUB, and become a shareholder, you must first complete the **100 Club Entry Form** which is also available on the website. Once complete either email or post/deliver to the Promotor Allen Brown at allenloveandlight@gmail.com or post to 7 Valley Way Stevenage Herts SG2 9AB.

The 100 CLUB consists of people who together have purchased numbered ONE POUND shares, to raise funds for this good cause in a monthly private society lottery.

Shareholders can have as many ONE POUND shares as they wish. Payment for the shares is made by Direct Debit or Standing Order, via the appended Entry Form, which is downloaded completed and returned to the promoter at allenloveandlight@gmail.com or, to his above address. An updated shareholder list will be sent to Lesley James by the 22nd of each month as the designated organiser of the 100 club.

Shareholders of THE 100 CLUB should purchase their ONE POUND shares in advance of the cut off day; the 22nd day any month; for the shares to be eligible for entry into that months draw.

Any share entered after the 22nd of the month will be entered into the following months draw. (The cut off day of the 22nd is to allow for Santander bank processing and also for the promoter to then allocate the total of ONE POUND numbered shares bought to that shareholder, and then confirm this to the shareholder by either email, text or mail.)

Each month the paid up ONE POUND shares are entered into the draw and the winner receives 50% of the money paid and entered up until the 22nd day of THAT month. *As an example, if there is forty pounds in ONE POUND paid up shares that month the prize will be twenty pounds. This sum will increase as further ONE POUND shares are purchased, but will always be 50% of the amount of paid up shares. (Once 200 shares is reached further guidelines may be issued.)*

The Total money in the month's DRAW is announced at the time that the DRAW is taken. The promoter will ensure that every month 50% of the ONE POUND paid up shares will be paid out in one prize.

Shareholders can change or cancel their total number of shares at any time.

For standing orders made by paper copy bank Direct Debit or standing order.

Notify the promoter who issues them a new standard entry form, to be completed and returned via email or to above address of the promoter. The promoter will notify the bank as soon as practical after the receipt of the notification change. The change in the number of shares will automatically be based on the amount in pounds stated on the form. Shareholders can also cancel any standing orders via their bank at any time, but must also notify the promoter.

For online standing orders

Members can cancel any exiting standing order via their Paypal account and create a new

standing order, if desired, using the online application form. If cancelling their standing order they must also notify the promoter.

Shareholders can withdraw any or all of their shares at any time up to and including the 22nd day of the month. Shareholders do this by notifying the promoter by text, email or telephone, and on confirmation from the promoter, by text, email or telephone they then cancel their direct debit or standing order with their own bank.

On the LAST DAY of each month shareholders paid up numbered shares will go into the draw. The number will be drawn using a number generating App such as Random.org. At that time, that number is declared the winner, and 50% of the money paid into the 100 CLUB that month, is then paid to that shareholder.

An email or text is then sent out to ALL shareholders of the 100 CLUB, giving them the details of the total amount in the 100 CLUB account that month, the total of the prize that will be awarded, and the share number and first name of the winner.

The Draw is held at 18 The Muntings Stevenage Herts SG2 9DN, or any other designated location, at the end of each month unless there is an event which falls on, or close to, that date at which it is applicable to DRAW the private lottery winner and, if present, present their prize.

In the event of any problem within the 100 CLUB, an independent adjudicator will be appointed and their decision will be final.
